E-Mail Registration Sweepstakes

OFFICIAL RULES

1. ELIGIBILITY: NO PURCHASE NECESSARY. NO PURCHASE WILL INCREASE YOUR ODDS OF WINNING. BWG Registration Sweepstakes is open to all residents of Massachusetts (and Massachusetts only) who register on-line for the Breakstone, White & Gluck E-Newsletter, and who are over the age of 18. Employees of Breakstone, White & Gluck, P.C., as well as immediate family members (spouses, children, parents, siblings) and those living in the same household as employees and directors, are not eligible to participate. Eligibility will be determined in the sole discretion of Sponsor. By entering, you agree to these Official Rules and to all decisions of the Sponsor, which are final and binding. 2. TO ENTER: To enter go to www.bwglaw.com/sweepstakes, click the link to register for Email Newsletter, and then complete the registration to subscribe to our Email Newsletter. You must have a valid e-mail address, and you must provide all necessary contact information including a valid mailing address and phone number. Registration must be completed by 11:59:59 on February 15, 2010. Incomplete registrations will be disqualified. If you do not have a valid e-mail address, you can enter by sending a 3 x 5 inch index card, with your name, address, and phone number to the Sponsor. Be sure to write “Registration Sweepstakes” on the envelope to qualify your entry. Mailed entries must be postmarked no later than February 15, 2010. Limit of one (1) entry per person. Incomplete or garbled entries and entries without the requisite contact information will be disqualified. Entries generated by a script, macro or other automated means are not eligible.

3. DRAWING and PRIZE: There will be a single prize awarded, and that will be two (2) tickets to the Boston Celtics vs. Indiana Pacers, on March 12, 2020 at the TD Bank Center in Boston. The face value of this prize is \$320. Prize winners will be selected by a random drawing by the Sponsor on February 15, 2009. Odds of winning a prize depend on the number of eligible entries received. Potential winners will be notified by email within five (5) business days after the drawing and must claim the prize by signing and returning a declaration of eligibility and liability/publicity release within five (5) business days of notification. If a potential winner cannot be reached within five (5) business days after the first attempt to contact such potential winner, or if potential winner does not timely return the signed claim forms, that potential winner will be disqualified and an alternate entrant will be selected in at random from among all remaining eligible entries. Any applicable taxes or fees on prizes are the sole responsibility of winner. Limit one

A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.
